

REINKE SHAKES LT SHINGLES

LIFETIME LIMITED WARRANTY



REINKE SHAKES, a Division of Jami Kari, LLC (hereinafter “Company”) hereby warrants to the original natural person residential purchaser (hereinafter “Owner”) of REINKE SHAKES LT SHINGLES (hereinafter “Product”), for as long as Owner owns the structure on which the Product is installed, or for a period up to fifty (50) years from the date of purchase, whichever is longer and as hereinafter limited:

Wind Warranty: (not applicable to Reinke Copper LT shingles) The Product will never blow off under any weather conditions including tornado and hurricane winds, provided the nails have held securely to the roof structure. ALL NAIL HEADS MUST HAVE PULLED THROUGH THE SHINGLE IN ORDER FOR IT TO BE DETERMINED THAT A SHINGLE FAILED.

Hail Warranty: Product will withstand UL 2218 Class IV rated hail impacts. Product will also withstand hail impacts under Company’s own Class V standard of a 2 1/2 inch steel ball dropped from 25 feet resulting in no hole, split, crack or other opening completely through the shingle.

Dent Warranty: (not applicable to Reinke Copper LT shingles) Product will not dent from normal foot traffic and hail up to thirty (30) millimeters in diameter. Hail size and wind velocity shall be determined by the records of the national, state and local weather services or bureaus; and THE EXISTENCE OF HAIL OVER THIRTY (30) MILLIMETERS IN DIAMETER IN THE AREA OF INSTALLATION AFTER DATE OF PURCHASE SHALL VOID THIS DENT WARRANTY.

Leakage Warranty: The underlying roof membrane and/or ice and water shield, is an integral part of this roofing system and it must maintain its integrity to shed water such as normal condensation that accumulates under metal roofing. Product is warranted to be free of any voids that allow water penetration. FAILURE OR DEGRADATION OF THE UNDERLYING ROOF MEMBRANE AND/OR ICE AND WATER SHIELD SHALL VOID THIS WARRANTY AGAINST LEAKAGE.

Paint Finish: Reinke Shakes specifies a baked-on fluorocarbon, or equivalent, color coating of a strength and quality to be applied before the metal is formed into shingles. COMPANY DOES NOT EXPRESSLY WARRANT THE PAINT FINISH. Paint supplier's warranty may transfer to the Company's customer. Product can be repainted if a color change is desired.

Warranty Exclusions: All warranties exclude leakage or other damage caused by:

1. failure or degradation of the underlying roof membrane and/or ice and water shield;
2. failure, degradation, deterioration, or destruction of the structure on which the Product is installed;
3. roof vents, vent flashings, snow blowing into vents, antennas, TV dishes, skylights, chimneys, protruding walls extending above the roof and bordering the edge of the shingles, or similar structural components or accessories;
4. application of harmful chemicals, cleaning solutions, coatings, or other surface modifications to the Product;
5. failure to follow manufacturer’s installation instructions; or
6. misuse, neglect, improper installation, improper storage or handling before, during or after installation.

Replacement Policy: A written notice of defect or breach of warranty and a copy of the original proof of purchase must be mailed to Company at the address below, contain the name and address of Owner or subsequent transferee(s) of Owner, and a detailed description of the defect or breach of warranty.

Company shall have the right to the return of the damaged shingle for inspection and testing. Company will replace free of charge after proof of defect or breach of warranty, one new shingle for each damaged shingle. Company will NOT guarantee an exact color match, will NOT pay for installation or other labor, and will NOT pay for shipping and handling or any other related damages or expenses.

The replacement of a shingle under this Lifetime Limited Warranty shall not extend the original term thereof.

THE COMPANY SHALL HAVE NO LIABILITY FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT OR SPECIAL DAMAGE OR LOSS OF ANY KIND WHATSOEVER (INCLUDING BUT NOT LIMITED TO DAMAGE CAUSED BY LEAKS).

THERE SHALL BE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE BEYOND THE TERM PRESCRIBED BY THE LAWS OF THE STATE IN WHICH THE PRODUCT IS SOLD. SOME STATES DO NOT ALLOW EXCLUSIONS AND LIMITATIONS OF IMPLIED WARRANTIES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.

OWNER'S SOLE REMEDY IS THE REPLACEMENT OF THE SHINGLE FOR ANY BREACH OF WARRANTIES.

This Warranty gives you specific legal rights and you may also have other rights which vary from state to state. Some states do not allow limitation or exclusion on implied warranties, or on incidental or consequential damages, so the above limitation or exclusions may not apply to you. This warranty only applies to shingles sold in the United States and Canada. This warranty applies to shingles sold after April 2, 2019.

Limited Transferability: This Lifetime Limited Warranty is only applicable to original natural person property Owners of a single family property on which the Product is installed and to the first subsequent transferee of such property.

The warranty for any other type of building owner or further transferees shall be fifty (50) years from date of original purchase and only after such other type of building owner or subsequent transferee has mailed to Company at the address below the original proof of purchase, the property address, the name of original owners, and date of transfer from original or subsequent transferee.
